Gábor Sulyok is a Senior Research Fellow at the Department of European Union Law and International Law at the Institute for Legal Studies, and a Full Professor of public international law at Széchenyi István University and Károli Gáspár University with more than two decades of experience in the research and teaching of international law. His fields of research include international peace and security, humanitarian intervention and the responsibility to protect, the sources of international law and the history of international law, but most recently he focuses on various fields of international space law. He is a member of National University of Public Service's Space Law and Policy Research Center and a lecturer of "UniSpace" space-oriented interdisciplinary postgraduate training programme. He conducts normative investigations by applying the traditional methods of legal doctrine, but also resorts, as appropriate and necessary, to other research methods.
